- (2) To educate and sensitize the incoming senior classes about the consequences of ragging.
- (3) The anti-ragging team should conduct surprise visits to the hostels, the cafeteria, and other student hangouts at least once every day for the first three months after a new class is admitted till further orders.
- (4) To increase security vigilance in high-risk areas like hostels, the cafeteria, the gym, the library, and the dining hall. Night duties and floor duties of specially ACER members and Non-ACER members is to be allotted.
- (5) All department Heads/ Coordinators should talk to their classes about ragging during orientation programme and during the first few classes.
- (6) If any incidences of extreme violence are witnessed by parents, they should notify college administration.
- (7) All seniors and juniors must sign the undertaking in UGC anti-ragging website.
- (8) Formation of campus ambassadors to be held on the campus.
- (9) Student handbook and joining notification need to be circulated among students so that they become aware of the campus business function before arrival.

- (1) To sensitize and address new upcoming and senior batches about ragging, its rules and its punishments during orientation program.
- (2) The anti-ragging teams should conduct surprise day and night patrols of the hostel, the cafeteria, and other common areas, particularly during the first three months after a new class has been admitted till further orders.
- (3) Appoint a mentor for every 20 students so that they can all receive individual attention, and have all students sign an anti-ragging pledge.
- (4) During classes, department heads and coordinators should talk to students about the issue of ragging like past year floor duty is must.
- (5) To increase security in high-risk areas, such as hostels, the cafeteria, the mess hall, college corners, the library, the campus, and other similar buildings and areas.
- (6) Request that any parents who become aware of ragging incidents on campus contact the school administration.
- (7) All seniors and juniors must sign the undertaking in UGC anti-ragging website.
- (8) Formation of campus ambassadors to be held on the campus.
- (9) Student handbook and joining notification need to be circulated among students so that they become aware of the campus business function before arrival.





- (4) To enhance security measures in high-risk areas such as hostels, cafeteria, gymnasium, library, and dining hall. Assigning night duties and floor responsibilities to both ACER and non-ACER members respectively.
- (5) All department heads/coordinators should deliver talks on ragging to their respective classes during orientation programs and the initial few sessions.
- (6) If parents witness any incidents of extreme violence, they should promptly notify the college administration.

- (7) All senior and junior students must sign the undertaking on the UGC anti-ragging website.
- (8) Organization of campus ambassador's formation to take place on the campus.
- (9) Students should be provided with a student handbook and joining notification to familiarize themselves with campus operations prior to their arrival.
