### Memorandum of Association

**1. Name of the Association**

The name of the Association is "Quantum University Alumni Association". The Association is registered with the Registrar of Societies, Uttarakhand under The Societies Act. Hereinafter referred to as "QUAA"

**2. Office**

The Registered office of the Association is **C/o LMD Education and Research Foundation, Mandawar, 22Km Milestone Kanjibans, NH73 Roorkee, Uttarakhand 247667.**

**3. Area of Operation**

- 3.1. The area of operation of the Association shall be in Uttarakhand.
- 3.2. A local chapter can be founded in any city of India or abroad whose bye laws may be formed by the office bearers at such time subject to approval of the Patron
- 3.3. A meeting of all the members of the association shall be held at least once a year.

**4. Aims and Objective**

- 4.1. To actively work towards bonding and networking of the Quantum University Alumni across the globe.
- 4.2. To foster a sense of belonging with the alma mater among the alumni members by organizing various campus connect programs and events such as the reunion dinners, alumni sports day, etc. at the University as well as in other cities.
- 4.3. To engage the alumni towards the overall growth and development of the alma mater by generating donations and contributions to strengthen the University infrastructure.
- 4.4. To bring value addition to current students by sourcing resourceful alumni members as well as others who are domain experts, industry leaders, motivational speakers, etc through guest lectures, seminars, workshops, training programs, webinars, etc.
- 4.5. To actively guide and support Q-Mates for their internships, industry integration, placement, etc.
- 4.6. To felicitate and confer awards, scholarships etc on the meritorious students of the University to promote excellence.
- 4.7. To impress upon members to be the brand ambassadors of the University by acting as responsible citizens and constantly work towards leveraging the goodwill of their alma mater.
- 4.8. To promote knowledge driven and technology based ventures among the students, faculty and alumni body.
- 4.9. To exhibit a sense of belonging for fellow Q-Mates and to be available for career guidance, hand holding and logistical help to their juniors for their work, study or stay in different cities both in India as well as abroad.
- 4.10. To establish, promote and support promotion of science, literature, music, drama and fine arts, which will benefit the university and QUAA.

- 4.11. To support the President, Board of Trustees, staff, faculty and student body of the University in their efforts to improve the institution.
- 4.12. To advise and interact with state and central government bodies, universities and associations of other academic institutions on matters relating to the promotion of higher education, training and management systems and thereby culminating promotion, welfare and status of the University.
- 4.13. To bring out magazines, souvenirs and newsletter highlighting the activities of the University and its Alumni.
- 4.14. To bring encouragement towards Innovation and nurture the Innovative ideas among the student community.
- 4.15. To award the distinguished alumni for their significant achievements and contributions.
- 4.16. To extend support to a needy alumni member of a retired faculty member/staff should the case so merit.
- 4.17. Though primarily not a social service organizations, the QUAA must act as a socially responsible and sensitive organizations to take up issues of social importance and provide assistance, whether financial, medical or any other to those in need irrespective of caste, creed, religion etc.
- 4.18. To have chapters of the Association within India and abroad for the furtherance of the objectives of the QUAA.
- 4.19. To carry out such other activities as may be necessary for furthering the aims and objectives of QUAA.

#### 5. Organization of QUAA:

**Patron:** Chancellor, Quantum University, shall be the Patron of QUAA. He shall be the permanent "Special Invitee" by the executive council for the meetings. He may be represented at the meetings by a designated officer in case of his unavailability.

**The Executive Council:** The executive council shall include the President, Vice President, Secretary, Treasurer and 4 nominated members. Total 8 members.

One such nominated member shall the person holding the position of Head, Dept of External Program (DEEPRO) at Quantum University or as decided by the Patron. This person shall hold office at the pleasure of the Patron.

At least one such nominated member should preferably be a female. However, in case of unavailability of a female member, the position may be filled by a male member.






