QUANTUM UNIVERSITY SCHOLARSHIP POLICY **RULES AND GUIDELINES**

The Rules and guideline for University scholarship policy framed u/s3.02 (15) kof the First Statutes and u/s8(2)e of the Quantum University Act of 2017, to facilitate the students. The Admissions Committee instituted by the University shall be the authority to scrutinize the application and recommend eligible candidate names for the award of scholarship and/or tuition waiver as applicable. The Vice Chancellor shall be final authority to approve the award of the scholarships.

Section A: Quantum University Scholarship Schemes.

- General Guidelines for Scholarships
 - a) All the scholarship disbursement/adjustment shall be annual and one time in first year fee only except in cases mentioned.
 - b) All requests of such students who have taken admission at Quantum University shall be made to the Admissions Committee as per the format provided along with all the relevant documents.
 - c) Department shall maintain a proper dedicated file for such request which has to be submitted in the Registrars' Office.
 - d) Student must apply for scholarship to avail scholarship facility.
 - e) The University shall scrutinize the application for scholarship.
 - f) Scholarship is not given in cash but adjusted in tuition fees only after payment of the remaining part of the fees.
 - g) Applicants should not have been suspended for any grave act of indiscipline by the university.
 - h) The applicant should not be receiving any other scholarship from any other source whatsoever, for which a certificate signed by student & parents is to be provided.

2. Siblings Scholarship

3. Financial Support Scholarship

This scholarship is available to applicant student based on his / her financial conditions. This scholarship will solely be given on the $discretion \ of the \ University \ authority \ and \ not \ as \ a \ right. \ Scholarship \ Amount \ shall \ also \ be \ calculated \ as \ per \ the \ need \ and \ availability.$

Supporting document to avail Scholarship:

a. Mishappening with parents: Student must submit the copy of Death certificate

4. Scholarship for ward of faculty/staff members of Quantum University

Scholarship Amount: 25% of tuition fee or Rs. 25000/- whichever is less (for all the years of the duration of the program).

Eligibility Criteria for Scholarship:

- a. The faculty / staff is in continuous employment under Quantum University for last 3 years.
- b. This scholarship is valid only till the faculty / staff continues to be an employee of Quantum University.
- c. If the faculty / staff leaves the employment (removed / retrenched / resigned / discontinued) the amount of scholarship for that year is to be paid back by the student.
- d. Attendance should not be less than 80% in next coming semesters.
- e. To continue the financial support in next coming semester student must maintain CGPA 28.0.
- f. No backlog in the previous session.

Supporting document to avail Scholarship for ward of Faculty/Staff members of Quantum University

- a. The familty / staff joining letter.
- b. Self-signed letter from the faculty / staff about continuing to be an employee of Quantum
- c. Self-size ad letter from the faculty/ staff far paying back the amount of scholarship if he/she leaves the employment (removed / retrenched / resigned / discontinued) for that year.

5) Alumni Scholarship

This se planship is available to applicant student if he / she has done their previous degree from Quantum University and are an Alumni of the University. This scholarship is applicable for all the years of the program in which the applicant wishes to study.
