Welfare Regarding Fee Waiver Provided to Faculty Members for Higher Education

Quantum University acknowledges the significance of fostering the welfare and professional growth of our esteemed faculty members. In adherence to this commitment, we have established a comprehensive fee waiver program tailored for faculty members pursuing both PhD and M.Tech programs. This initiative embodies our dedication to nurturing a culture of continuous learning and scholarly advancement within our faculty community.

1. Eligibility:

All full-time faculty members employed by Quantum University are eligible to apply for the fee waiver program for Ph.D and M.Tech programs offered by the university.

2. Scope of Fee Waiver:

The fee waiver covers tuition fees associated with both Ph.D and M.Tech programs. However, additional expenses such as examination fees, study materials, and any other incidental charges are not covered under this program.

3. Application Process:

Faculty members interested in availing the fee waiver must submit a formal application to the designated administrative office responsible for academic affairs. The application should include:

- a. Evidence of enrollment or admission into the PhD or M.Tech program.

- b. A justification statement outlining the relevance of the program to the faculty member's professional development and academic goals.

Additionally, the provision of fee waivers for faculty members enrolled in M.Tech and Ph.D programs at Quantum University aims to encourage their pursuit of higher education while balancing professional responsibilities. This initiative signifies our commitment to supporting faculty members personal and professional development, which ultimately enhances the quality of education provided to students.

The university recognizes the financial challenges associated with pursuing advanced degrees and thus offers fee waivers of Rs. 40,000/- to alleviate some of the financial burdens for faculty members.
